OFFICE MEMORANDUM

Subject : Termination of MOA and de-empanelment / removal of 02 Units of Currae Eye Care Centre at A.J.C. Bose Road Unit and Madhyamgram Unit from the list of empanelled HCOs of CGHS, Kolkata – regarding.

The following QCI recommended HCOs of **Currae Health Care Centre (a Unit of Patni Healthcare Private Limited (PHPL))** are presently empanelled under CGHS, Kolkata w.e.f date shown against their name :

- 1. Currae Eye Care Centre, AJC Bose Road (a unit of Patni Healthcare Pvt. Ltd.) 1A, Acharya Jagadish Chandra Bose Road, Elgin, Kolkata, West Bengal – 700020, empanelled w.e.f 20th January 2018.**
- 2. Currae Eye Care Centre, Madhyamgram (a unit of Patni Healthcare Pvt. Ltd.) 106 (N), Near Madhyamgram Crossing, Jessore Road, Madhyamgram, Kolkata, West Bengal - 700129, empanelled w.e.f 10th October 2018.**

As per letter No. Nil dated 31st October 2019 received from Currae Eye Care Centre (a unit of Patni Healthcare Pvt. Ltd.), a business transfer agreement was executed between Patni Healthcare Private Limited (PHPL) and New Delhi Centre for Sight Limited (NDCFS) on 4th October, 2019 and will be effective from 19th November, 2019.

As per Memorandum of Agreement (MOA) signed between the Competent authority of CGHS, Kolkata and authorized signatory of Currae Eye Care Centre (a unit of Patni Healthcare Pvt. Ltd.) the following clause of MOA has not been followed by the said HCO and it is a case of gross violation of MOA.

“Should the Hospital/Exclusive Eye Centre/Exclusive Dental Clinic/Diagnostic Laboratory/Imaging Centre get wound up or partnership is dissolved, the CGHS shall have the right to terminate the Agreement. The termination of Agreement shall not relieve the hospital or their heirs and legal representatives from the liability in respect of the services provided by the Health Care Organization during the period when the Agreement was in force.”

In view of the fact stated above it is clearly informed that **the above mentioned HCOs are hereby de-empanelled and removed from the list of empanelled HCOs with effect from 19th November, 2019 as per clause of MOA mentioned above and the MOA of \ the said HCOs are also terminated w.e.f 19th November, 2019.**
